Dear Rev. Scott and Laura,

I present to you the WiFi Upgrade Project for your consideration.

Since returning to the building after the early stages of the pandemic, access to the internet has declined somewhat rapidly, both by LAN (ethernet cable) and by WiFi on both the public and private (staff) networks. We upgraded to a faster internet plan which dramatically helped internet access by LAN so that we could provide quality Zoom offerings.

However, WiFi performance continued to degrade. After detailed inspections by several vendors, Parker determined and I concur that the problem lies with the internal network that sends WiFi signal throughout the building. In fact, the now outdated WiFi system is throttling internet service, decreasing the speed by 90% between LAN and WiFi. In November 2022, Parker met with a few vendors and found that fixing this internal WiFi system would cost about \$4,000. Having no budget for AV/IT improvements in the 22-23 fiscal year, we put the project on hold until the next budget cycle.

Sometime in December, there was a complete failure of the existing WiFi booster that provides service to the main office and conference room. This cripples many vital meetings which require internet access by multiple people. The conference room especially is not wired to host many laptops for LAN access and, further, modern computers don't have ethernet ports which causes a challenge in finding and utilizing adapters. Additionally, more and more event rentals require WiFi access for scores and even hundreds of guests. We run the risk of becoming obsolete and unable to host fundraising events for nonprofits at our space.

It is my recommendation that the Board immediately approve funds for the WiFi Upgrade Project to improve function for both internal and external events. I have attached the roughly \$4,000 estimate from Farquhar Tech for formal authorization from the Board at your February meeting.
